The scope of the verification covers Snap, Inc (Snap) calendar year (CY) 2020 GHG Emissions Inventory with the following boundaries:

- **Organizational Boundary:** 55 sites

The Snap GHG inventory was prepared to, and verified against, the WRI/WBCSD GHG Protocol Standard Revised Edition dated 2015.

Based on the method employed and the results of our verification activities, Cameron-Cole has found no evidence of material errors, omissions or misstatements in Snap's CY2020 GHG Inventory within the boundaries described above. Cameron-Cole also found that Snap's GHG accounting and calculation methodologies, processes and systems for this inventory conform to the WRI/WBCSD GHG Protocol Standard Revised Edition dated 2015.
